

In the background is South Brisbane, the river and the first permanent Victoria Bridge under construction. The photograph was taken from the Bank of New South Wales corner. President's Report

In the May issue of this report, reference was made to a meeting held by the immediate past president (Dean Prangley) and I with David Edwards, the Project Chief Executive at the Department of Innovation, Tourism Industry Development and the Commonwealth Games concerning our right to occupy the Commissariat store after our lease expires in 2028. The meeting was convened as members of our Council were concerned that the Casino, which has commercial incentives, may not be keen to renew the lease to a voluntary organisation with not for profit and public benefit objectives. During our discussions, Mr Edwards assured us there was no reason to be concerned and that it was a term of the not to be disclosed agreement between the Department and DBC that they must make available the Commissariat Store to the RHSQ on existing terms for the duration of DBC's 99-year lease. In other words, the RHSQ has a right to occupy the premises for the duration of the 99-year term. Mr Edwards promised to send a letter of comfort confirming this position. Well the letter has arrived. True to his word, Mr Edwards confirmed the Casino (DBC) is required to renew the lease on the same basis that currently exists. This is great news, so our tenure is assured for the future. However, in the future we still have to negotiate who pays the outgoings costs- but this was always the position.

During most Thursdays and on other days during the week, many members of the various committees are sitting around the table working on their various subject matters. This week the awards committee has deliberated on the recipients of the many awards that are offered annually. These prospective candidates will be presented to the Council for consideration at the July meeting. Furthermore, representatives from the PHA and the RHSQ met and jointly made a selection of the 2018 recipient of the John Kerr Medal of Distinction.

Discussions are continuing with respect to the Dig Tree and the issues concerning grant compliance. This should be achieved in the near future.

Further, I have now become a member of the Cooktown Advisory Committee that is organising the events leading up to the June 2020 events in Cooktown. As previously stated, we are convening three history conferences in 2020, one in Brisbane, one in The Town of 1770 and another in Cooktown to celebrate Captain Cook's encounter with the Australian coastline. Broadly, these conferences will be substantially from an Aboriginal perspective. Recently, the Commonwealth Government announced money in the budget for a new facility at Botany Bay to celebrate Cook's arrival, but nothing was announced for the events elsewhere. Negotiations are continuing on this issue.

I remind you that the Queensland Day Dinner is being held on 6 June at the Brisbane Club. I hope to see you there.

Queensland News

Allora – PL Travers Park in Allora was opened on 23 April 2018 by Assistant Minister for Veterans' Affairs and Assistant Minister of State, Ms Jennifer Howard MP. The Minister also opened the Southern Downs Council's Allora streetscape project and an exhibition at the Allora Court House to celebrate the history of the building. The Allora Historical Society was very involved in the organization of the historical preservation projects and events. (Warwick *Daily News* 21 April 2018 p. 3)

Cooktown – The 80 years old historic mango tree in front of the Cooktown Court House is to be removed. An arborist has reported that it is hollow. In 2005 Cooktown people petitioned successfully for its retention. Local people have been picking the mangoes each year since. (*Cape York News* 4-10- April 2018 p. 9 including photograph)

Gympie - Steam engine C17 974 and 3 Kuranda cars were scheduled to arrive at the inter-facepoint between the Mary Valley Rattler and Queensland Rail on Wednesday, 2 May 2018 at about 4.45pm. This will be the first steam operations on the Mary Valley Rattler lines since October 2012. (Email - Tony Hallam, Mary Valley Rattler – 20 April 2018)

Kuranda - On 4 April 2018 the Department of Environment and Science (the Department) received an application from a member of the community proposing entry of the **Avenue of** *Ficus Microcarpa* **and** *Ficus Obliqua* **trees** in the Queensland Heritage Register as a State Heritage Place.

Mareeba – The Mareeba Tobacco Selling Floors building in Chewko Road are to be demolished. The building was built in the 1950s and is said to have been the largest tobacco display floors in the southern hemisphere. Cairns based Anton Demolitions Pty Ltd are removing the steel work and flooring. The building contains 20,000 lineal metres of red tulip oak flooring in good condition. It will be retained for resale. (*Tablelands Advertiser* 27 April 2018 p. 6 including photograph).

Warwick – Mrs Janice Flood performed the opening of the Southern Downs Heritage Festival at St Marks Anglican Church on 20 April 2018. St Marks Church has been celebrating the 150th anniversary of the foundation of the church building in 1868. Mrs Flood noted that the heritage festival stimulates interaction between community organisations. (Warwick *Daily News* 21 April 2018 p. 2 including photograph)

Winton – The Waltzing Matilda Centre is being re-opened three years after the fire. Winton's Way Out West Festival will help celebrate the centre's rebirth. 7,000 people are expected for the event. Chillagoe - On 17 May 2018 in Chillagoe the Society's Honorary Secretary, Dr Ruth Kerr, presented one of the Society's Centenary Medals to Mary Bolam of Chillagoe, north Queensland. Mary is a history and

heritage advocate for the region and has worked hard since the 1980s to preserve the Chillagoe smelters site, the Court House and Railway Station. She has also been a constant advocate for improved roads and has collected stories about the prominent families in Chillagoe and Mungana history.

The respect with which Mary Bolam is held for her work was demonstrated by the attendance of the Mayor of Chillagoe Shire, Tom Gilmore, and three Councillors Lenore Wyatt, Mary Graham and Edward ('Nipper') Brown together with approximately 35 Chillagoe Alliance Inc members, townspeople, Auctus Resources mining company managers and Historical Society members from Mareeba. Mr Tom Prior drove one of his antique Ford utilities to the event.

The event was held in the historic Chillagoe Court House which is now a museum and a lunch was held afterwards in the Chillagoe Town Hall.

The Wednesday talk for June

Okinawan 'pearling specialists' in Torres Strait and the end of the Queensland pearlshelling industry, 1958-1963.

The north Queensland pearl shelling industry resumed in 1946 without its pre-war Japanese indentured labour force. Despite high prices for shell, the shortage of skilled workers meant that the master pearlers could not exploit the deepest beds. They lobbied for permission to import their highly skilled pre-war Japanese indents, a deeply unpopular proposal, arguing that Indigenous divers were unable or unwilling to dive to the depths required. This seminar is based on an unpublished 2016 paper, 'A failed experiment: Okinawan indents and the post-war Torres Strait pearl fishery, 1958-1963', and outlines the background to Queensland's decision to import 'Okinawan pearling specialists' to Thursday Island in 1958. This 'Okinawan experiment', a relatively unknown episode of post-war Queensland social, political, economic and Indigenous history, set against the normalisation of Australian-Japanese relations, coincided with the end of the industry. It was universally considered a failure but the Okinawans were not only to blame: equally at fault were the master pearlers and the three governments involved.

Speaker: Dr Anna Shnukal

Dr Anna Shnukal is a linguist who has lived on and off in Torres Strait since 1981. Currently an Honorary Associate of the Queensland Museum, she has produced almost 100 books, book chapters, journal articles, government reports, bibliographies, conference papers, reviews and seminars on aspects of Torres Strait language, ethnography and history.
